### **ASSISTANCE FOR SERVICE STATIONS THAT DID NOT MEET THE APRIL 1, 2009 PHASE II EVR DEADLINE**

Under stipulated Order of Abatement and settlement agreement with AQMD, facilities not able to meet the deadline, will be required to take the necessary steps to comply with Rule 461 as quickly as possible, but no later than **December 31, 2009**.

In addition, facilities will be assessed a monthly penalty to encourage early compliance. If a facility is not yet in compliance by **September 1, 2009** penalties will increase based on the amount of gasoline throughput.
